Vendor space is assigned upon receipt of payment. Each vendor must return the registration form with a check or money order form of payment to reserve a space.

**The deadline for reservation is July 31, 2024.** After the deadline spaces will be assigned by availability. Electric hookups are available on a limited bases for a \$10 fee per day. The vendor is responsible for electrical cords and adapters. May need 100-200ft cord to reach.

**All vendors must park their vehicles in the parking lot across Highway 179** once they have completed their unload.

**Vendors are required to purchase wristbands for each person 12 years of age and older.** You can include the cost of your wristbands in your vendor costs and will be provided with those wristbands at registration table when you arrive.

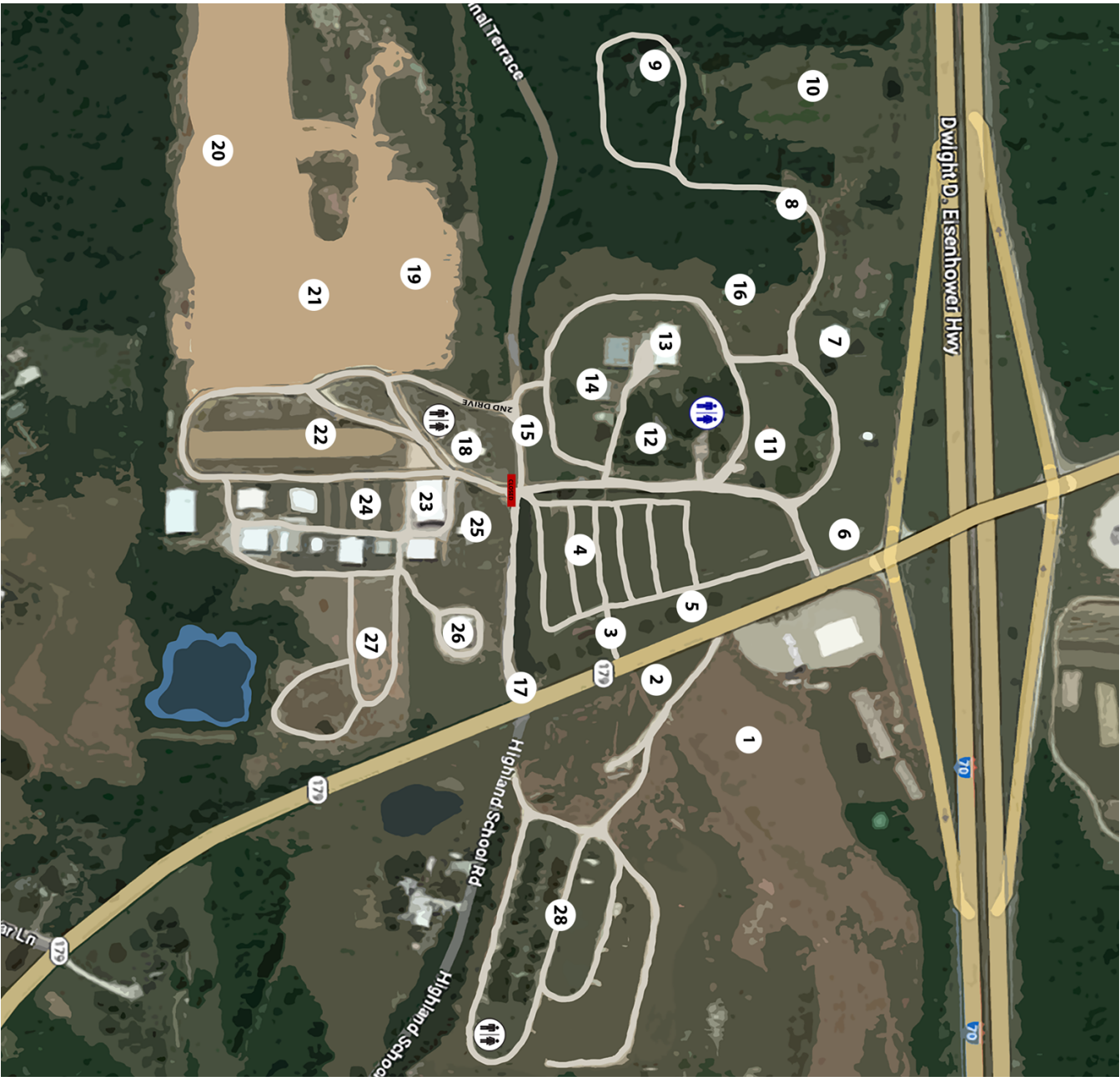
