Vendor space is assigned upon receipt of payment. Each vendor must return the registration form to reserve a space. Vendors can include a check or money order with your form, or pay cash when you arrive at the grounds. **The deadline for reservation is July 31, 2025.** After the deadline spaces will be assigned by availability. Electric hookups are available on a limited bases for a \$10 fee per day. The vendor is responsible for electrical cords and adapters. May need 100-200ft cord to reach. All vendors must check-in at the Flea Market Office prior to unloading at your spot. **All vendors must park their vehicles in the parking lot across Highway 179** once they have completed their unload. **Vendors are required to purchase wristbands for each person 12 years of age and older.** You can include the cost of your wristbands in your vendor costs and will be provided with those wristbands at registration table when you arrive.

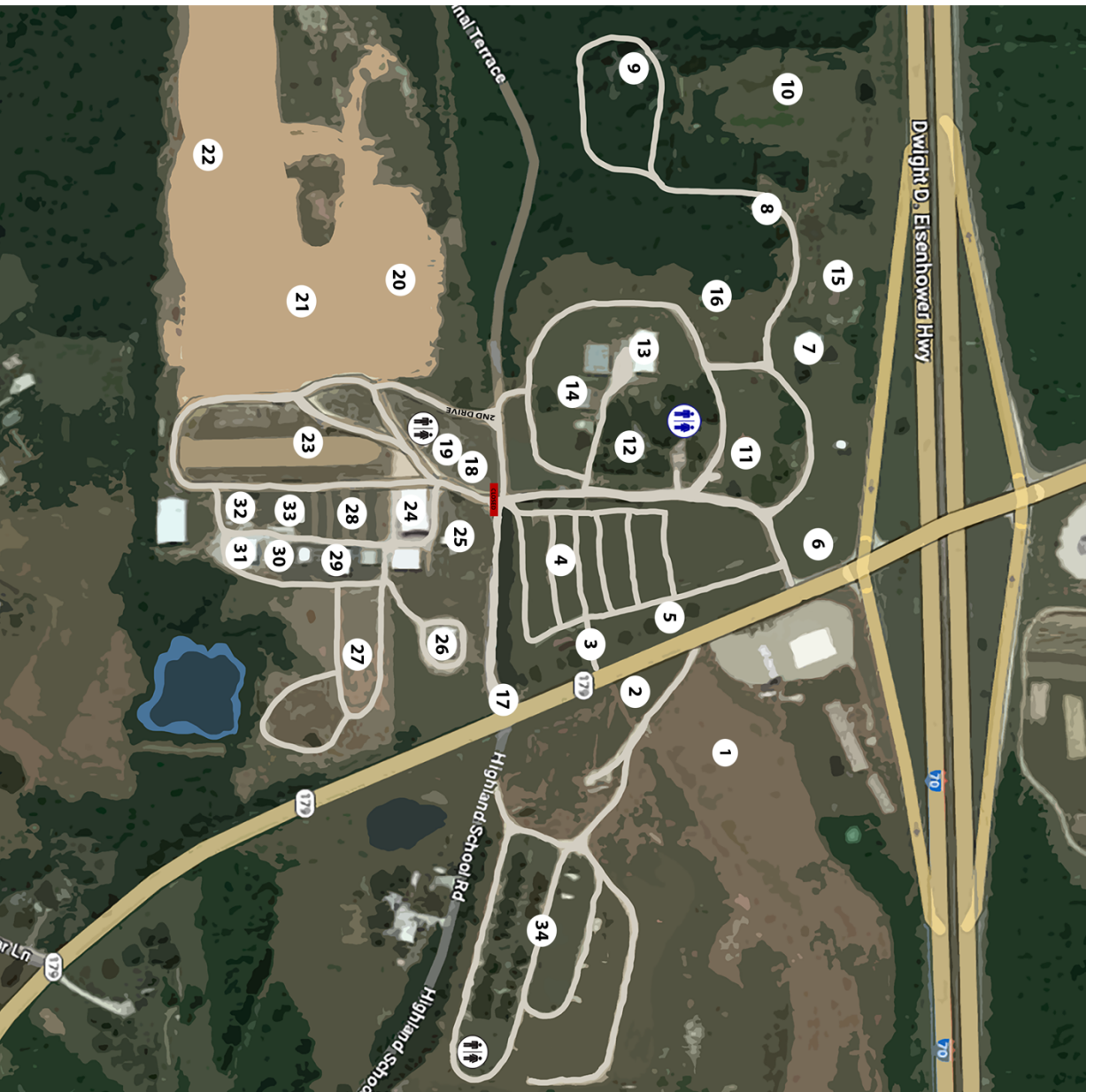
