### **PLEASE READ CAREFULLY:**

- Vendor spaces are assigned upon receipt of a completed vendor form. Each vendor must submit this form to reserve a spot; without it, we cannot guarantee space.
- Payments can be included with the form via check or money order, or paid in cash upon arrival.
- The reservation deadline is July 31, 2027. After that, spaces are assigned based on availability.
- Electric hookups are limited. Available for a 10-dollar daily fee. Vendors are responsible for electrical cords and adapters, possibly needing 100-200 foot cords.
- All vendors must check in at the flea market office before unloading.
- All vendors must park their vehicles in the parking lot across highway 179 once they have completed their unload.
- Wristbands are required for anyone age 12 and up, and you can include their cost in your vendor fees. Wristbands will be provided with your receipt.

## **RULES FOR THE FLEA MARKET**

### **PLEASE READ CAREFULLY**

1. ALL LICENSES, SALES TAX, OR PERMITS REQUIRED BY THE STATE OF MISSOURI ARE THE RESPONSIBILITY OF THE VENDOR
2. **NO SALE OF:** any sexually explicit materials, firearms, weapons, knives, drugs and drug paraphernalia.
3. **CHECK-IN:** All vendors must check-in at the Flea Market Office prior to unloading at your spot. Do not go to your spot without checking-in.
4. **WRISTBANDS:** Vendors are required to purchase wristbands for each person 12 years of age and older. You can include the cost of your wristbands in your vendor costs and will be provided with those with your receipt of payment.
5. **PARKING:** While a vendor is allowed to park their vehicle in their space, it must fit within the space(s) purchased. If your vehicle does not fit in the space purchased, vendors must park their vehicles in the parking lot across Highway 179 once they have completed their unload. Do **NOT** park in an empty space, aisle, road, or random grass space. This can lead to your vehicle being towed. If you cannot park in a purchased space, park across the highway and walk back into the flea market area to avoid issues.
6. **ELECTRICAL CORDS AND ADAPTERS:** Vendors are responsible for electrical cords and any adapters needed to use electrical power if purchased. You can need up to 200ft cord to reach the pole. You must come prepared with cords and adapters needed. Your space will not be moved because you do not have the cords to reach the electrical pole.
7. **USE YOUR SPACE:** Use only the space you pay for. Do not put anything into another space empty or occupied. You will be asked to move your items only once.
8. **SETUP DAY:** Do your best to show up on Tuesday to setup, if you cannot arrive on Tuesday – communicate that to the Flea Market Coordinator. If you have problems along the way, call to let us know.
9. **CANCELING:** If you cannot make it to the show, please call prior to the show or as soon as you know. Do not ask someone else to call for you. The vendor purchasing space needs to be the one to call to cancel.
10. **IT IS OUR SPACE NOT YOUR SPACE:** Do not yell at/disrespect anyone if you do not get the same space as a previous year. You do not own the space given to you, the MRVSEA owns the space. And the Flea Market Coordinator works hard to provide spaces to returning vendors as best as they can, but at the end of the day they are only human, and you may not get the exact same space.
11. **NO YELLING/DISRESPECTING OTHERS:** Do not yell at anyone regardless of your emotional state. The Flea Market Coordinator has a lot on their plate and will not be talked to in a manner that disrespects them. And other vendors do not deserve to be yelled at or disrespected either. It is the goal to show each other respect and courtesy at this family-oriented show.

If you fail to follow any of these rules, you will be asked to leave the grounds immediately. Your fee will not be refunded and you will not be allowed to return to the show in future.
